## What Types of Situations Can Give Rise to Personal Injury Claims in North Carolina?

Under personal injury law – also called tort law – a legal action can be brought by a Raleigh personal injury lawyer on behalf of an injured person (called the plaintiff) who is seeking damages for losses he or she suffered following the negligent or intentional act of another (the defendant). Situations that give rise to personal injury lawsuits in North Carolina are:

- [Car Accidents](#)– people who have been injured in car accidents often face a long road to recovery. And while the insurance company may seem like they are here to help, they ultimately want to pay as little on your claim as possible. Accident victims who don't work with a Wilmington, personal injury lawyer may settle their claim for far less than it is worth, finding that they have losses that they will never be able to recover. - [Truck Accidents](#)– because of their size and weight, truck accidents are more likely to result in catastrophic injuries when compared to accidents involving private passenger vehicles. However, these accidents are complex for other reasons, namely the potential liability of the trucking company and other parties. Some of

the common causes of truck accidents include mechanical failures, violations of trucking regulations, unsecured loads, and driver errors due to insufficient training and inadequate supervision. - **Boating Accidents**- boaters have a legal duty to use due care when on the water. Unfortunately, this duty is often overlooked because there are no signs, lanes, or other visual reminders to help keep people safe. Add in the fact that many boaters are under the influence of drugs or alcohol and can quickly find themselves in a very dangerous situation. A negligent boat driver can cause an accident in the blink of an eye, leaving you with severe injuries and other losses. - **Motorcycle Accidents**- motorcyclists are especially vulnerable in the event of an accident. Unfortunately, they also face an unfair bias when they need to pursue a claim. - **Bicycle, Scooter, and Pedestrian Accidents**- motorists have a legal obligation to avoid accidents and share the road, an obligation that extends to pedestrians, bicyclists, and scooters. Despite public campaign efforts to the contrary, these accidents still happen all too frequently, typically resulting in severe injuries and sometimes death. - **Industrial Accidents**, including Fires and **Explosions**- industrial accidents such as fires and explosions often result in very serious injuries involving multiple people. Determining the cause of the accident and who should be held accountable can be a significant challenge, especially for the victims. If you have been injured in an industrial accident, you need a Wilmington personal injury lawyer on your side. - **Construction Site Accidents**, including Falls and Electrocutions- construction sites can be very dangerous places for their workers, and accidents can happen in the blink of an eye. - **Certain Workplace Accidents**- workers' compensation is a vital safety net for our injured workers.
