

[Truck accidents](#) in Raleigh and elsewhere around North Carolina have the potential to result in high-impact injuries or catastrophic damages. When such accidents occur, victims often feel shaken and unsure about what to do next. However, taking the wrong steps could negatively impact your ability to receive full compensation for injuries and damages and could even jeopardize your well-being and life in general. ## Check for Injuries and Call 911

First, check yourself and your passengers for injuries, as well as those in the other vehicle(s). If anyone is injured, seek medical help and call 911. If you are able to, move your car to the side of the road to help prevent additional accidents. Also, turn on your hazard lights to alert other drivers.

Please note that some injuries are not immediately apparent but may manifest later as a medical emergency, so do not hesitate to seek medical treatment as soon as possible if necessary.

## Take Photos of the Accident Scene, If Possible

Use your phone to take pictures and videos of the accident scene, including vehicle damage, skid marks, road conditions, and any visible injuries. This visual evidence can be crucial for your case. Collect contact and insurance information from the truck driver and any other drivers involved. Note the truck's license plate number, company name, and any identifying numbers on the truck.

If there are any witnesses, ask for their contact information and a brief statement of what they saw. Witness testimonies can be valuable evidence in supporting your claim. **Do not admit fault or make any statements that could be interpreted as admitting fault.** Stick to the facts when speaking to the police and other drivers.

## Seek Medical Attention and Keep All Injury-Related Documentation

After leaving the scene, make an appointment with a healthcare provider for a thorough medical evaluation and abide by your medical provider's recommendation. Keep all pertinent medical records, and be sure to note all medical treatments, diagnoses, and expenses incurred as a result of the accident. You will need this for your claim.

## Gain an Understanding of the Relevant Laws

Under North Carolina's contributory negligence laws, if it can be shown that you were responsible in any way for causing the accident, you can be barred from financial recovery. This is why choosing the right attorney is so important to your liability determination. Your attorney is going to work hard to show that you were not guilty of any carelessness that contributed to your accident. Additionally, your attorney will present evidence, interview witnesses, and use an accident reconstruction expert whose report will likely be used in litigation if you decide to go to court.

Insurance companies want you to think that a settlement is the best option for you; however, your attorney may demonstrate that a more generous level of compensation is available to you.

## Be Sure to Take All Damages Into Account to Get Maximum Compensation

Consider all damages when filing your claim. Economic damages include medical expenses, lost wages, and property damage. Keep detailed records of all these expenses related to the accident. Non-economic damages include pain and suffering, emotional distress, and loss of enjoyment of life. Your lawyer can help quantify these damages. Be prepared for the possibility of going to trial if a fair settlement cannot be reached. Your lawyer will represent you in court if necessary.

Also, as noted above, follow your healthcare provider's recommendations and participate in recommended rehabilitation programs. Depending on the situation, you may want to consider obtaining counseling or mental health services to help you through the emotional trauma that typically accompanies serious accidents.
